POSITION SUMMARY:

The Child Watch Attendant will work with the Program Director to promote the highest quality service. The Child Watch Attendant will also support the Program Director with oversight and development of all child watch services.

ESSENTIAL FUNCTIONS:

1. Develops, implements, and manages operating plans to promote program growth for the YMCA. Executes strategies to ensure that program participants connect with one another and connect with the YMCA.
2. Directs and supervises program activities to meet YMCA objectives. Expands the Child watch services within the community in accordance with strategic and operating plans.
3. Develops and maintains effective working relationships within the community.
4. Assures compliance with state and local regulations. Ensures that program standards are met and safety procedures are followed.
5. Assists in the marketing and distribution of program information.
6. Responds to all member and community inquiries and complaints in timely manner.
7. Monitors and evaluates the effectiveness of and participation in the program.

QUALIFICATIONS:

5. Completion of YMCA program-specific certifications.

3. See and observe all sections of an assigned zone or area of responsibility.
